A senior White House official and several lawmakers said Wednesday they were unaware of evidence suggesting that a Trump campaign adviser or some members of his inner circle had any contact with Russian agents.

The bureau issued a search warrant for Trump Tower's office in June 2016 to review thousands of emails between Trump's transition team and members of the Russian government that were among those reviewed by the FBI, the officials told The Washington Post, including those from campaign manager Paul Manafort and then-national security adviser Michael Flynn.

The government said at the time it had not found reasonable grounds to believe Mr. Bongino was planning to violate the law by reporting the sexual assault. Assistant U.S. Attorneys Eric Miller and Elizabeth Brown had asked for the order for Mr. Bongino to be barred from testifying.. The Washington Post reported Friday that the FBI contacted House Intelligence Committee Chairman Devin Nunes — an Arizona Republican.. FBI director James Comey revealed in a September news conference the bureau was investigating whether Trump or someone else ordered a wiretap on Trump Tower, a White House statement later said. White House press secretary Sean Spicer didn't offer any further details about the inquiry late Wednesday, after Trump issued a statement Wednesday night saying he is not under investigation by the FBI, the official said.. Mr. Bongino, who had been involved in a sexual assault case, was a defendant last October, when a federal jury decided he must register as a sex offender on the basis of false reporting. banks.. Story Continued Below The White House also was not aware of any coordination between Trump's team and the Russian government, the official said, declining to offer specifics.. After being ordered to register, Mr. Bongino went into hiding in Brooklyn with a roommate. That roommate's lawyer said that because prosecutors had not shown a reasonable basis to believe that he was planning to offend, he lost the right to see him.. The decision to give Mr. Bongino immunity marks the first time that the civil rights courts allowed a civil rights lawyer to serve as a defense consultant to a federal defense counsel.. U.S. Attorney Robert Capers has said he expects to HD. The FBI is investigating whether President Donald Trump's campaign colluded with the Russians and whether there were any contacts between Trump associates and Russian officials at Trump Tower in New York on Nov. 8, according to multiple officials familiar with the matter.. "At no time in their investigation do we have ever been in a position to confirm or deny whether there was any coordination between the Trump campaign and any foreign government," he said.. Criminal lawyers have a very limited and narrow role in the criminal justice system, the New York Times added. They typically serve as counsel to defendants and their legal teams.. A New York lawyer who was barred from the courtroom for a week in May for making false statements was given new immunity as part of the lawsuit.. Mr. Bongino's lawyer, Charles J. Mr. Lynch, noting that both sides had requested the order on the same day, said Mr. Bongino did have the right to be present through the public defender's office, and also the right to a lawyer as part of the civil action..
